Most solar modules are transported further within Europe by truck. Especially in Germany and the EU, road transport is often the fastest and most flexible way to reach even remote locations. However, transporting solar modules is not an everyday freight - they are sensitive and must be handled properly to avoid damage.

What are the regulations for solar panels?

The regulation requires you to correctly label your product, packaging, or accompanying documents, such as the instruction manual. You should provide product-specific warnings with your product. Note that some warning requirements may come from certain standards. This section lists several examples of standards for solar panels.
