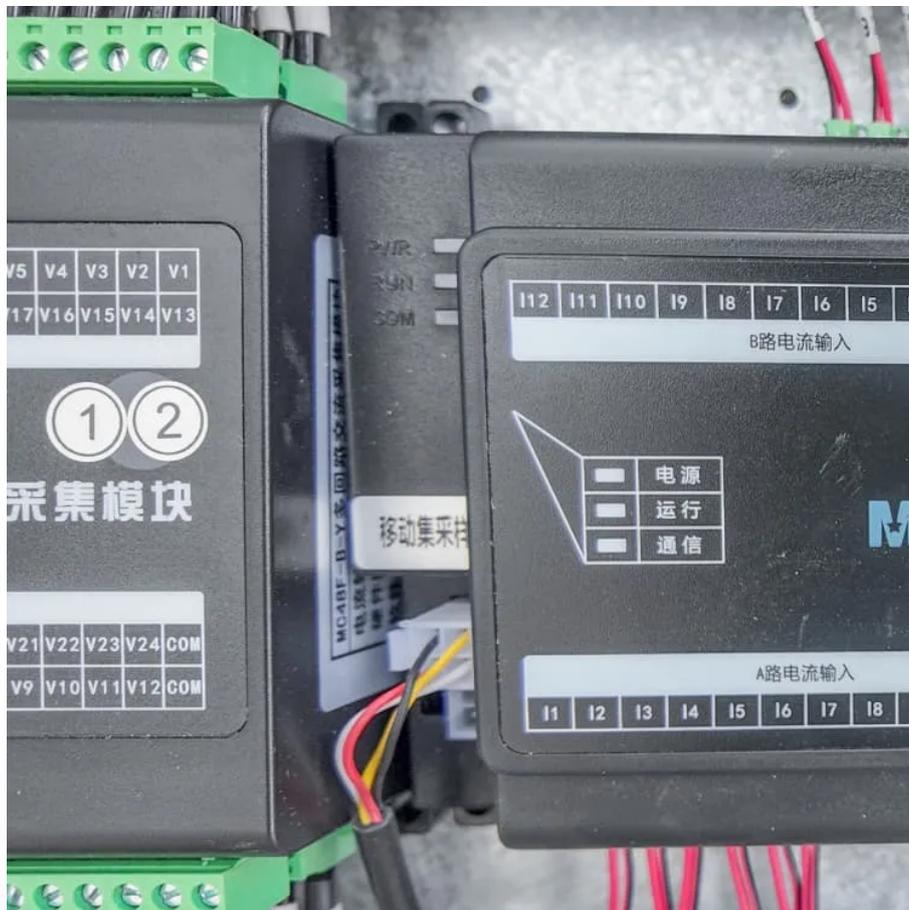

Should Australians sell solar power back to the grid?

How does solar energy work in Australia?

You use a portion of that electricity for your household or business needs. Excess energy is exported back to the grid. Your energy retailer pays you a feed-in tariff for each kilowatt-hour (kWh) you export. This system enables Australians to recoup part of their investment by selling solar power they don't consume.






